

# **UI Tax Account Reactivation Guidance**

# Reactivating or Registering a UI Tax Account in Iowa

If your business previously had an Iowa Unemployment Insurance (UI) tax account and has resumed employment in Iowa, you may be eligible to reactivate your existing account. However, depending on how long the account has been inactive, a new registration may be required.

## **Account Status Definitions**

#### **Automatic Inactivation**

Accounts with eight consecutive quarters (two years) of no wage reporting or zero wages are automatically placed into an inactive status.

- If 10 or more quarters have passed since the last wages were reported, the account may be too old to reactivate.
- In such cases, a new UI tax registration must be submitted.

#### **Manual Inactivation**

Accounts may also be inactivated manually:

- By request from the employer or their agent
- By Iowa Workforce Development staff upon receiving a formal request

The same reactivation rules apply as with automatic inactivation (see page 3 for Reactivation Timeline Chart)

### What You Need to Reactivate

Refer to the Reactivation Timeline Chart on page 3 to determine if the account can be reactivated.

- If your account can be reactivated, contact Iowa Workforce Development with the following information:
  - o Previous UI account number or Federal Employer Identification Number (FEIN)
  - Date employment resumed in Iowa
  - Date paid wages resumed in Iowa
  - Any outstanding quarterly wage reports
- If the account is not eligible to reactivate, please register for a new account a www.myiowaui.org.

Example: Last quarter wages were reported is 1/21. The 10<sup>th</sup> quarter with no wage's lands in 3/23, so 2023.

If wages resume anytime on or before 12/31/2023, the account will be Reactivated.

If wages resume on or after 1/1/2024, the account will not be Reactivated, and a new Registration is required.
