More Counties Added to Disaster Unemployment Assistance Announcement from May Benefits Now Available to Residents in Three More Impacted Counties.

DES MOINES, IOWA – Federal authorities have added three more lowa counties to the list of places where individuals are eligible for Disaster Unemployment Assistance (DUA) following severe weather a month ago. Iowa Workforce Development is now accepting applications for DUA from individuals in Adams, Cedar, and Jasper Counties whose employment or self-employment was lost or interrupted due to the severe storms, tornadoes, and flooding that occurred on May 20-21, 2024.

A previous announcement made such benefits available to residents in Adair, Polk, Story, and Montgomery Counties. Impacted individuals can start applying now. Applications must be filed by July 23, 2024.

Eligibility

To be eligible for DUA benefits under Presidential Disaster Declaration FEMA-[DR-4784-IA], individuals:

- Must be an unemployed or self-unemployed worker whose unemployment was caused as a • direct result of the major disaster declared by the President; and
- Must be a U.S. national or a gualified alien; and .
- Must be unable to qualify for regular unemployment insurance benefits from any state; and
- Must have worked, been self-employed in, or been scheduled to begin work or self-employment • in one of the counties listed above; and
- Must establish that the work or self-employment they can no longer perform was their primary . source of income.

Also eligible to apply for DUA are individuals who:

- Can no longer work or perform services because of physical damage or destruction to their place of employment as a direct result of a disaster; or
- Cannot perform work or self-employment because of an injury caused as a direct result of the disaster; or
- Became the breadwinner or major support of a household because of the death of the head of • the household: or
- Cannot work or perform self-employment due to closure of a facility by the federal government. .

What You Need

- Individuals will need their Social Security Number and the name and address of their last employer or prospective employer to file for DUA.
- Applicants are required to provide proof (at the time of filing or within 21 days of filing their DUA claim) that they were employed or self-employed at the time the disaster occurred or were scheduled to begin (or resume) a job or self-employment when the disaster occurred.
- A copy of the most recent federal income tax forms or check stubs may also be required (selfemployed individuals should also provide Schedules SE and Schedule C or Schedule F).

Deadline

Applications filed after July 23, 2024, will be considered untimely, unless the individual provides good cause for filing after this date. Individuals can receive up to 26 weeks of DUA benefits as long as his/her unemployment continues to be a result of the disaster. Eligibility for DUA benefits will be determined on a week-to-week basis.

How To Apply

Individuals who may be eligible for assistance, must file a claim online with <u>lowa Workforce</u> <u>Development's Unemployment Benefits Online Application System (workforce.iowa.gov).</u>
