DON'T FORGET

Overdue Apprentices

Each sponsor is expected to be diligently tracking the On the Job Learning (OJL) and Related Instruction (RI) that each apprentice is earning. It is critical that each Sponsor monitor time to completion and work to actively "complete" each apprentice once they have fulfilled the requirements and expectations of their RA program.

Our team (as well as Department of Labor) monitors the amount of apprentices whose records are "overdue". Our team will continue to notify Sponsors if/when there are overdue apprentices but it is the responsibility of the Sponsor to keep your RAPIDS records up to date and document completion for apprentices in a timely manner.

Wage Schedule

As a reminder, it is important that all apprenticeship program sponsors follow their wage progression schedule outlined in their standards. To maintain program compliance, once an apprentice has completed all required training each sponsor must ensure the apprentice is paid the ending journeyworker wage outlined in the program standards. Please note, the final wage is not dependent on the apprentice sitting for and/or passing state licensure exams. If you have any question regarding your program wage schedule, please contact your Apprenticeship Program Coordinator.

OCCUPATIONS THAT REQUIRE LICENSURE

The lowa Office of Apprenticeship as a state agency will help to uphold and enforce state licensure requirements for any occupation that require licensure in the State of Iowa. This means we will ask (and at times) require confirmation of licensure documentation for your organization and/or journeyworkers. Some occupations even require licensure for an apprentice. This means that your program may be required to provide confirmation or documentation of licensure documentation for your organization and/or journeyworkers.



It is critical that Sponsors in licensed occupations, monitor and maintain licensure to stay compliant for their RA program.

- For any apprentice for whom earns OJL and/or RI under an individual or organization for which is not licensed, can result in having those earned hours vacated, delaying the time to completion.
- If you or your apprentice has questions about proper licensure for your occupation, feel free to reach out to the Iowa Office of Apprenticeship and we can help connect you to the appropriate licensing board.

Managing RAPIDS RAPIDS is an essential database for helping manage your Registered Apprenticeship programs. We strongly encourage all Sponsors to log into and review RAPIDS data at least once a month to help maintain RA program records.
