

# Ames Metropolitan Statistical Area Iowa Workforce Development 2021 Profile



## **Jobs Summary**

The Ames Metropolitan Statistical Area (MSA) was home to 43,744 jobs in 2020, representing 3.0 percent of covered employment in lowa. Government accounted for 13,660 positions, making it the MSA's largest supersector by employment. State government alone employed 7,837 individuals, largely due to workforce requirements at the local university. Among private industries, trade was the largest supersector, employing 6,155 people. The coronavirus pandemic caused employment in




the MSA to decline by 5.3 percent from 2019 to 2020; however, the MSA's average annual wage increased by 7.3 percent year-over-year.

# Number of Firms by Industry, 2020





## **Commuting Patterns**

- → 43.2 percent of workers lived fewer than 10 miles from their primary place of employment, while 35.2 percent had a one-way commute of 25 miles or greater.<sup>2</sup>
- → 49.7 percent of the MSA's employees lived in the area, meaning a small majority of the area's employees commute into the region from the surrounding communities.<sup>2</sup>
- $\rightarrow$  72.6 percent of workers drove alone to work, while only 13.5 percent utilized carpooling or public transportation.<sup>3</sup>
  - 14.3 percent of workers under 25 walked to work, compared to 2.8 percent of those 25 and older.<sup>3</sup>
